


Substance Use Disorder Director's Report September 2020

- 1. 1915 (c) HCBS Waivers/Substance Use Disorder (SUD) Site Review: MDHHS has communicated with the LRE that they will be conducting a full site review which will include: SUD, Children's Waivers Services, Habilitation Supports Program, and Waiver for Children with Serious Emotional Disturbance (see the attached letter). The site review will be conducted October 19-December 4 remotely/desk review. More information on this will be forthcoming as we prepare materials and connect with the state on this.
- 2. Drug Free Coalition of Muskegon-Attached please find a 10-year evaluation of all the work and effort that the coalition has accomplished in Muskegon County. There is much to be proud of in that community!
- 3. Synar: Is a federal requirement to ensure tobacco isn't sold to minors from tobacco outlets (i.e. gas stations). If the state's overall sales rate is more than 20%, Michigan can lose SUD federal block grant dollars. Consequently, Synar checks are very important and this year OROSC randomly selected 30 tobacco retailers in our region to be inspected. The LRE and the DYTUR's (Designated Youth Tobacco Use Representatives) in each county conducted these inspections as prescribed using an underage decoy and 14% of the retailers sold to minors. Please note that this year all decoys were wearing masks and very few retailers asked to have them pull the mask down or check ID. We believe that had a negative impact on our numbers as it is hard to gauge a person's age only looking from their eyes up. We also had two retailers who no longer sell tobacco products due their closure. The chart below demonstrates the Synar rates since becoming a region.
