### I. PURPOSE

This policy ensures Lakeshore Regional Entity (LRE) and Member CMHSPs have a robust Behavior Treatment Plan (BTP) Review Committee program and process that complies with all contractual standards.

The purpose of the PIHP Behavior Treatment Plan Review Committee is to provide consultation, guidance and oversight as required through the MDHHS/PIHP Master Contract.

#### II. POLICY

It shall be the policy of the LRE to ensure the review and approval/disapproval of treatment plans are consistently implemented across the Region and meet all standards for the Behavior Treatment Plan Review Committee (BTPRC) process in accordance with the Michigan Department of Health and Human Services (MDHHS)/Prepaid Inpatient Health Plan (PIHP) Master Contract and the MDHHS Technical Requirement for Behavior Treatment Plans and Behavior Treatment Plan Review Committee

### III. APPLICABILITY AND RESPONSIBILITY

This policy applies to the LRE and all Community Mental Health Service Programs (CMHSP) members.

#### IV. MONITORING AND REVIEW

This policy will be monitored and reviewed by the Chief Executive Officer or Designee on an annual basis.
